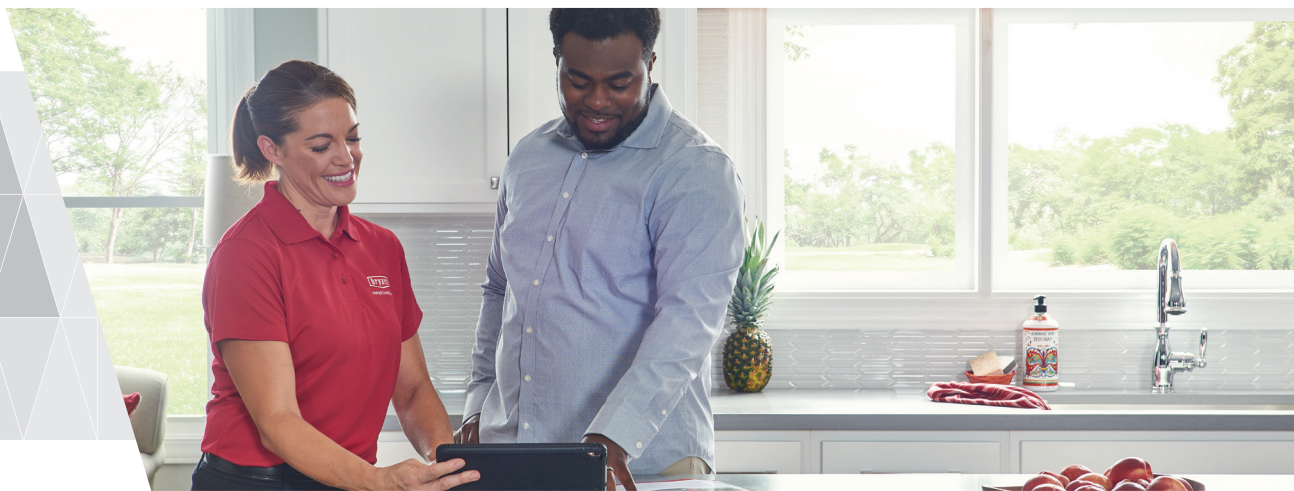




BRYANT RED SHIELD 10-YEAR UNIT REPLACEMENT WARRANTY

When it comes to such a major investment, there's no better gauge of quality.

What is the Bryant Red Shield Warranty?

The Bryant Red Shield is a one-time use 10-year unit replacement limited warranty that is available only to the original homeowner who purchased the unit. If any of the products listed below fail due to a qualifying major component defect during the applicable unit replacement limited warranty time period, a one-time replacement with a comparable Bryant unit will be provided. This unit replacement warranty is in addition to the standard parts warranty. Please see the product warranty cards for full details.

Does the Bryant Red Shield Warranty override the standard Bryant parts warranty?

No. On the products listed below, you will receive 10 full years of parts limited warranty[†] coverage and the Bryant Red Shield one-time use 10-year unit replacement warranty. Two great warranties delivering double the peace of mind to homeowners.

How do you register for the Bryant Red Shield warranty?

As with the parts warranty, the unit must be registered within 90 days of installation on bryant.com. We suggest you work with your installing contractor to ensure timely registration. The unit replacement warranty will default to a five-year unit replacement limited warranty if registration is not completed within 90 days of installation.

Is the Bryant Red Shield warranty transferable to a new homeowner if the house is sold?

No.* The unit replacement limited warranty applies only if the claimant is the original purchaser of the product. Proof of purchase and installation date will be required.

[†] If properly registered within 90 days of original installation, otherwise five years (except in California and Quebec and other jurisdictions that prohibit warranty benefits conditioned on registration).

* In Texas and other jurisdictions where applicable, subsequent owner's warranty duration shall match that of original owner (10 or five years, based on registration), as described in applicable law.
